#### **MANUFACTURING AND PACKAGING (A1-A3)**

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

Uponor Q&E is manufactured by injection moulding process with PE-RT raw material. The fittings are supplied to the construction site packed in cardboard boxes on pallets. Installation instructions come with each pack.

#### **MANUFACTURING PROCESS**



#### **TRANSPORT AND INSTALLATION (A4-A5)**

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

The transportation distance is defined according to the standard. Average distance of transportation from production plant to building site is based on the actual sales average figures of the company in of the local markets and the transportation method is assumed to be lorry. Vehicle capacity utilization volume factor is assumed to be 100 which means full load. In reality, it may vary but as the role of transportation emissions in the total results is small, the variety in load is assumed to be negligible. Empty returns are not taken into account as it is assumed that a return trip is used by the transportation company to serve the needs of other clients. Transportation does not cause losses as the products are packaged properly. Volume capacity utilisation factor is assumed to be <1 for the nested packaged products. Each wooden pallet is assumed to be re-used 120 times based on actual re-use scenarios.

Environmental impacts from installation into the building include waste packaging materials (A5) and release of biogenic carbon dioxide from wood pallets.

#### **PRODUCT USE AND MAINTENANCE (B1-B7)**

This EPD does not cover the use phase. Air, soil, and water impacts during the use phase have not been studied.





#### **PRODUCT END OF LIFE (C1- C4, D)**

Since the consumption of energy and natural resources is negligible for disassembling of the end-of-life product, the impacts of demolition are assumed zero (C1). The end-of-life product is assumed to be sent to the closest facility by lorry and is assumed to be 50 km away (C2). 100% of the end-of-life product is collected separately from the demolition site; 63% is sent to recycling, 36% to incineration facilities (C3) and 1% is sent to landfill (C4). Due to the recycling and incineration potential of PE, the end-of-life product is converted into recycled material while energy and heat are produced from its incineration (D). The benefits and loads of waste packaging materials in A5 are also considered in module D.





## LIFE-CYCLE ASSESSMENT

#### **CUT-OFF CRITERIA**

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

#### ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:


