



Available in dimensions from 40 to 75 mm in both metal (brass) and plastic (PPSU) versions, S-Press is the coupling that makes no compromises: Tough, safe, simple and smart. In addition, we have a full range of compression adapters, manifolds, mounting accessories and radiator connection fittings. The application areas are:

- Tap water installation: The permanent operating temperature ranges from 0°C to 70°C at a maximum permanent operating pressure of 10 bar. The short-term malfunction temperature is 95°C for a period of 100 hours in the operating lifetime.
- Radiant Heating and cooling: The permanent operating temperature ranges up to 80°C at a maximum permanent operating pressure of 10 bar. The short-term malfunction temperature is 100°C for a period of 100 hours in the operating lifetime.

This EPD covers S-Press fittings made from tin-plated DR brass CW 625N. Male and female threads are manufactured according to EN 10226-1.





MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.


Uponor S-Press is manufactured by forging (elbows, tees, tap elbows) and BAZ/turning (couplings, male & female straight) processes using brass (60% recycled).

The fittings are supplied to the construction site packed in cardboard boxes. Installation instructions come with each pack.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

The transportation distance is defined according to the standard. Average distance of transportation from production plant to building site is based on the actual sales average figures of the company in of the local markets and the transportation method is assumed to be lorry. Vehicle capacity utilization volume factor is assumed to be 100 which means full load. In reality, it may vary but as the role of transportation emissions in the total results is small, the variety in load is assumed to be negligible. Empty returns are not taken into account as it is assumed that a return trip is used by the transportation company to serve the needs of other clients. Transportation does not cause losses as the products are packaged properly. Volume capacity utilisation factor is assumed to be <1 for the nested packaged products. Environmental impacts from installation into the building include waste packaging materials (A5).






PRODUCT USE AND MAINTENANCE (B1-B7)

This EPD does not cover the use phase.

Air, soil, and water impacts during the use phase have not been studied.

PRODUCT END OF LIFE (C1-C4, D)


Since the consumption of energy and natural resources is negligible for disassembling of the end-of-life product, the impacts of demolition are assumed zero (C1). The end-of-life product is assumed to be sent to the closest facility by lorry and is assumed to be 50 km away (C2). 100% of the end-of-life product is collected separately from the demolition site and recycled. Due to the recycling potential of brass, the end-of-life product is converted into recycled material (D). The benefits and loads of waste packaging materials in A5 are also considered in module D.






MANUFACTURING PROCESS











LIFE-CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:


